Morningstar User Agreement for ByAllAccounts Service

This Morningstar[®] User Agreement for ByAllAccounts[®] service (the "Agreement") is a legal agreement between you and Morningstar, Inc., ("Morningstar") for the ByAllAccounts service, as defined below. In this Agreement, the terms, "service" or "ByAllAccounts service" means consolidating and presenting to you in an organized fashion certain information from your accounts with financial and investment institutions and other sources of information (each of these institutions or information providers, an "Account Provider") on secure web pages or other media. The term "You" or "you" means the company, entity or individual who is using the ByAllAccounts service under this Agreement - with "Use" being defined as storing, loading, installing, executing, displaying, retrieving, downloading, or otherwise processing information via the ByAllAccounts service.

Your Information and Authorization. In order to provide you with the ByAllAccounts service, Morningstar will collect, as you register for the ByAllAccounts service, your name, email address and certain other information as requested from time to time ("Contact Information").

In addition, for Morningstar to be able to access your Account Provider account information via the ByAllAccounts service, one or both of the following must occur:

- 1) For those Account Providers with whom Morningstar maintains a credentials-based connection for receipt of your account information, you must enter your online account access information, which may include your account number, user ID, password and/or personal identification numbers (PINs) specific to your account(s) ("Login Information"). You agree that your provision of such Login Information is your signature and authorization for Morningstar to serve as your agent in allowing you and Morningstar to access your Account Provider account information through and in conjunction with the ByAllAccounts service; and/or
- 2) For those Account Providers with whom Morningstar maintains a non-credentials-based connection, either via direct feed, API, or similar access, for receipt of your account information, the relevant Account Provider(s) will send Morningstar Your Account Provider account information upon your explicitly authorizing them to do.

By providing Your Login Information and/or authorizing your Account Provider to send Morningstar your Account Provider account information, you explicitly consent to Morningstar Using all Login Information and Account Provider account information to make the ByAllAccounts services to available hereunder, including, without limitation, Morningstar passing your Account Provider account information on to one or more platforms or services Used by you and/or your authorized agents to perform analysis on your behalf.

You may revoke your ByAllAccounts consent at any time through the ByAllAccounts application – either by deactivating your ByAllAccounts account with Morningstar (resulting in your revoking consent as to all

Account Providers) or by designating one or more Account Providers for whom you wish to revoke your consent. When you deactivate your ByAllAccounts account, we'll delete all your account information from the ByAllAccounts production environment.

You are responsible for and must provide all equipment, software (other than any software provided by Morningstar) and services necessary to access the ByAllAccounts service.

By posting updated versions of this Agreement on the ByAllAccounts service or otherwise providing notice to you, Morningstar may modify the terms of this Agreement, and may discontinue or revise any or all other aspects of the ByAllAccounts service in its sole discretion and without prior notice. All such changes shall become effective upon posting of the revised Agreement on the ByAllAccounts service, as to your future use of the ByAllAccounts service. The updated, on-line version of this Agreement shall supersede any prior paper or other media-based copies of this Agreement that may have been included in any software or related materials provided by Morningstar.

Privacy. MORNINGSTAR WILL NOT SELL, EXCHANGE, OR RELEASE ANY OF YOUR CONTACT INFORMATION OR LOGIN INFORMATION TO AN UNAFFILIATED THIRD PARTY WITHOUT YOUR EXPRESS PERMISSION, UNLESS REQUIRED BY LAW OR COURT OR GOVERNMENTAL ORDER. NOTWITHSTANDING THE FOREGOING, MORNINGSTAR MAY USE CERTAIN THIRD-PARTY SERVICE PROVIDERS (E.G., AMAZON WEB SERVICES) FOR CERTAIN APPLICATIONS AND, AS A RESULT, PORTIONS OF YOUR INFORMATION MAY BE SENT TO AND/OR HOUSED ON SYSTEMS OPERATED BY THEM ON MORNINGSTAR'S BEHALF. You agree that you will be responsible for all usage of the ByAllAccounts service through your account and, to the extent any fees apply to your use, any fees associated with that use or the use of any other services accessed through the ByAllAccounts service on your account whether or not authorized by you.

Upon any such termination or expiration, you must discontinue all use of the ByAllAccounts service, and immediately destroy the Materials together with all copies. The provisions of this Agreement (other than your right to use the ByAllAccounts service) shall survive termination or expiration of this Agreement.

Controlling Law and Severability. This Agreement constitutes the entire agreement between you and Morningstar with respect to the ByAllAccounts service. This Agreement is governed by the laws of the State of Illinois without reference to its conflict of laws provisions. In the event of any dispute involving this Agreement, Morningstar and you each consent to exclusive jurisdiction and venue in either the state or federal courts in the Cook County, Illinois and agree that the prevailing party shall be entitled to its reasonable attorney fees and costs. In the event any provision of this Agreement shall be deemed unenforceable, void or invalid, such provision shall be modified to the extent needed to make it valid and enforceable, and as so modified the entire Agreement shall remain in full force and effect. No decision, action or inaction by Morningstar shall be construed to be a waiver of any rights or remedies available to it.

Waiver of Class Action. Except as otherwise specifically prohibited by applicable law, all disputes arising from or related to this Agreement, a party's performance hereunder or any of its acts or omissions (or any of the acts or omissions of any of its agents) will be adjudicated on an individual basis and not in a class or representative action or as a member of a class, mass, consolidated or representative action, irrespective of the forum in which they are heard. Any claim asserted by a you or Morningstar hereunder shall not be joined for any purpose with the claim or claims of any other person or entity, unless both you and Morningstar specifically agree to the joinder of the individual actions.
